- · Waiting for banquet receipts to come in
- Sponsors invoice for banquet sponsors of \$400 o/s
- Rothenberg is paid up with their \$2000 for this year.
- Healthy Heart has paid in advance 2 years ago
- Banquet will cost about \$19,000 including awards, and will collect about \$6000 from sales and about \$4700 from SA (will come in at the end of the year)
- It's anticipated that after the playoffs & banquet, the balance will be down to about \$18,000
- v. Director, Community Relations Ron Coggan
- Calgary City Civic Survey completed, and it has noted that the is a need for more courts
- Ron will be attending the annual sport meeting
- Ron met with Brent Johner, Racquet Network to confirm courts are booked for the rest of season but most players will disperse at the end of the season
- There is water damage at Banff Rocky Mountain Resort (BRMR) courts that will need to be repaired
- There has been private interest in the project to add courts in Canmore a min of 3 courts. A lease has been signed and now looking at rules from Canmore for construction. The timing of conclusion is unknown at this time. The global target is Sept 1 but that is an aggressive target right now. Too early to determine of they will be ready for next season Interclub
 - o Glencoe offered list of contractors that might be able to help BRMR with repairs.

ii. Player Eligibility

- 4th release of Penalty report has been released. There were 4 players playing on a higher level team. Only 1 team was affected due to the penalties. The matches were played in early January and were not caught until last week. Most of the matches played were penalized and almost 12 points were penalized. It affected all the teams in the division or level. It prevented the team from playing in the playoffs in 4th place, and resulted in the 5th level team moving up. This is was in Mens Level 7 Bow Valley and Fish Creek
- There were some penalty points issued during the Semi-finals playing. It was
 discovered during the entering of scores or through queries. It will affect the results
 for the playoffs this Saturday. A preliminary playoff schedule has been send out.

- The final matches will be posted on SportyHQ
- Reports for Players Eligibility were almost useless from SportyHq, although the old system wasn't perfect either. In order to do the player eligibility analysis, the information had to be exported into Excel, cleaned and then used. Very time consuming.
