- Craig Hutchings, Glencoe Club notes a change to bylaws was requested by Squash Alberta

 Executive Committee, to speak to any motion, issue, or matter under consideration at a
 Board meeting of the CISA
 - Changed to: 1.4 (b) Rights of a CISA member: The right to attend and upon recognition by the *Chairperson of the meeting*, to speak to any motion, issue, or matter under consideration at a Board meeting of the CISA
 - The change is to acknowledge that there might be a meeting where the full Executive Committee might not be in attendance.
- Ron Coggan, World Health revealed that he was the person that voted "No" to adopting the bylaws when it was presented to the Board for a vote
 - He still disagrees with the bylaws in particular with 1.6 stating that any one individual can represent only one Club at any given meeting

- 4. Committees

 - Nothing with ladies 2 at MRU, U of C, CWC but held hostage by other certain teams
 this year. Next year, how you finish will incur a movement not fair to other teams
 that want to move up or move down. Not much of an issue with level 1 (men or
 ladies) moving down as they are the ones that want to stay in level 1

- Latest version out of the Interclub team levels have been distributed. Please have feedback to Peter ASAP, as Steve Kaltenhauser want to start scheduling this Friday, August 19
- SAIT Ladies 1 might be at risk due to an injured player
- Fish Creek Mens 5 may need a player or two but might be able to fill with Mens 7 players
- Ladies 5 only has five teams this year which will cause an imbalance in scheduling

• Leona Faller is requesting to play Mens 1

Motion put forth by Ron Coggan, World Health:

Leona Faller requests to play Interclub at Mens Level 1 for World Health while playing Ladies Level 1 at World Health as a sub.

Seconded by: Ken Gellatly, Bow Valley

Voting is **UNANIMOUS**, Motion is **PASSED**

- Ron Coggan, World suggests an experimental policy or a modify to a current rule
 - i. There are teams that need a spare from time to time, so as not to default an interclub match. The proposal is to modify the spare policy to allow subbing between clubs within the same level. Intraclub subbing allowed only twice, with the third time locking the player to the that team. After the third time, the player is no longer allowed to play for another club
 - ii. Concerns of this proposal:
 - a. Craig Hutchings, Glencoe, brings up the concern or difficulty of tracking player eligibility.

- Alex Altamirano, Fish Creek, suggests that the captains learn the rules and apply it properly. Right now, SportyHQ does not check the rules frequently enough and penalties are assessed later
- Colleen Hicke, CWC, suggests that it could be unfair to the level if there is one 'ringer' that plays across the level but not evenly to all teams in the level
- d. Mariette Rabacal, World Health, questions the possibility of a player subbing across different levels and subbing up or down a level within a club when playing only two matches on each level. How would this be tracked or controlled to maintain integrity of teams

ACTION ITEM: Rules Committee to take a closer look at this proposed rule for the new season

d. Playoffs & Banquet

Colleen Hicke

- Invoicing and Revenue is complete for last year's playoff banquet
- Next year's (April 22, 2017) Playoff matches and Banquet needs a location
- Playoff location requires a minimum of 6 courts to host and banquet can be hosted outside of the club
- Changes also need to be made to attract more attendance food choice/style, poster, entertainment

ACTION ITEM: Let Colleen know by next meeting (Sep 21) if you are able to host the Playoffs matches. Also provide Colleen with any suggestions/ideas for the Banquet

- Currently, CISA charges \$50 per team to play Interclub. This has not changed for the last 10 years. For the 2016/2017 season, there are 137 teams
- Question was proposed to why individual membership fees could not be increased by \$5 per person.
 - i. For this year, it is too late, as the individual fee comes from Squash Alberta, and the 2016/2017 membership fees have already been established. Squash Alberta is willing to work with CISA to make this adjustment for next season (the 2017/2018 season)
- The CISA Board determines the team fees

Motion: To increase the team fees from \$50 to \$60 per team for the 2016 / 2017 season

Motion made by: Craig Hutchings, Glencoe

Seconded by: Ken Gellatly, Bow Valley Club

Discussion Concerns:

- Ron Coggan, World Health notes that budgets have already been discussed with the teams.
- Alex Altamirano, Fish Creek notes that there is a difference between being the rep of a club vs being the owner of a club. An increase is asking the owners to pay more with minimal notice at three weeks before the start of the season
- Arash Ardeshiricham, Fifth Avenue would need to talk to club owners about this increase and suggests postponing a decision until the next meeting
 - Peter Schwartz notes the next meeting would be too late for this season, as invoices will be distributed shortly. The additional incremental cost is \$10 spread over 6 players or \$1.67 extra per player
- Larry Allen, World Health asks why are we concerned with money when there's a balance of \$20K currently, when in the past a balance of \$5K or \$6K is enough
- Colleen Hicke, CWC, notes that every year the cost of the banquet keeps rising
- Ken Gellatly, Bow Valley indicates that sponsorship is not as strong as has been in the past
- Ron Coggan, World Health, notes that the cost of website development is an unknown
- Rick Spyker, Eau Claire Y feels that this increase is a small amount. For next season (2017/2018), we should work on getting some money from the individual players via Squash Alberta

Voting Results: In Favour/Yes = 14 Declined/No = 1

Motion is passed. Invoices will reflect the new cost of \$60 per team

- Ron Coggan, World Health, had an inquiry from Chris Watson, World Health, regarding the value of sponsorship on the SportyHQ website. How to make sponsors more visible? Ron is working with SportyHQ to make sponsorship more visible on the website
- No other news from sponsorship committee per Arash Ardeshiricham

- Peter Schwartz, Fitness Plus, suggests that the sponsorship committee move forward more aggressively, and would like know the status of past title sponsors
- Alex Altamirano, Fish Creek, commented on a promotion presented by Charles Fairs
 re: insurance quotes. The insurance rep would like the promotion extended to all
 Squash Alberta members offering \$25 to CISA for each quote to a max of \$500.
 The insurance rep also wanted to know where her logo might be on the SportyHQ
 website.
- Peter Schwartz, Fitness Plus, presents a request from Kevin Doucet, who would be willing to pay \$50 - \$100 to help promote his tournament in November in our next email delivery.

 - v. A hot button to enter scores but might bypass some sponsorship visibility
- Part of the goals is to be able to send the information to Squash Alberta with the
 push of a button. But it's not there yet. Currently, Squash Alberta's goal is to post
 ranking results weekly or bi-weekly because of more anticipated movement with the
 new ranking system. CISA is providing playing results monthly, due to the work
 needed to verify the results.
